ORDERING INSTRUCTIONS

HOW TO ORDER

Fax the attached order form to (310) 323-3942, 24 hours a day, or speak to one of our sales representatives at (800) 262-1126. We accept VISA, MC, American Express and checks. Open accounts extended to repeat customers OAC. Open account terms vary. Past due accounts subject to service charge. Customer is liable for collection and attorney fees. **Please note** - we do not ship COD.

SHIPPING AND FREIGHT CHARGES

Most shipments are made from Victory Display Gardena, or Long Beach, CA. Some items may be shipped from regional warehouses solely at our discretion or to reduce your shipping charges. Due to different points of origin, your order may not ship together, resulting in multiple freight charges. Victory Display does not control freight rates. We try to ship UPS. If size and/or weight is beyond UPS limits, we ship Common Carrier truck freight collect (meaning you are responsible to pay the carrier upon delivery). We can provide freight estimates, but actual charges may vary.

CLAIMS

All shipments must be inspected immediately upon receipt. Visible damage must be noted on bill of lading or receipt. Note: Victory Display is not responsible for damage in transit. It is the customers' responsibility to file damage claims. If necessary, Victory Display can assist in the claims process. Please save all packaging for possible inspection. Shortage claims must be made within 5 days of delivery.

RETURNS

No returns allowed without a written Return Authorization (RA) from Victory Display. Goods returned without an RA will be refused. No returns after 5 days. All authorized returns must be in original packaging and are subject to a 15% re-stocking fee. We retain the option to refuse returns not in original packaging or charge a 25% re-stocking fee. No returns of custom-made or special order (non-catalog) items. Customer pays all freight costs to return merchandise. Customers on account will receive credit towards future purchases. All others must request a refund.

MINIMUM ORDERS

Victory Display has a long-standing policy of no minimum order. However, under certain conditions, a handling fee may be assessed. American Express card purchases have a \$25.00 minimum.
